Following are some tips to write a good compare and contrast essay.

Generally, there are two approaches to write a compare and contrast essay, a point-by-point method, and a subject-by-subject method. Both of these methods are used in structuring and organizing the essay according to the requirements. Like others, a compare and contrast essay includes three major parts, an introduction, a body, and a concluding paragraph.

Let's look at how you can organize your compare and contrast essay by following two methods.

### **1- Point by Point Method**

In this method, you first state your point (s) and then compare and contrast both subjects against that point. Again, in the next paragraph, you give another point and compare it with reference to

the subjects. In this way, you organize your whole essay and at the end conclude it through [custom essay writing service](#)

## 2- **Subject by Subject Method**

Subject by the subject method is opposite to the point-by-point method. Here you compare and contrast one subject at a time and give your points. For instance, first, you discuss subject A and provide related points and then move to subject B. at the end, you summarize the two subjects and conclude your essay.

- **Brainstorming**

Before you start writing your essay, you should discover any similarities and differences between the subjects and note them.

- **Look for Focus of Your Essay**

Next, you should decide what is more important or a striking aspect of the subjects that you can use to further develop your essay.

- **State a Clear Thesis**

Every essay is an argument. A thesis statement is an essential part of an essay. It can help you stay focused and specific about the topic. Therefore, decide on a working thesis statement for your essay.

- **Organize the Essay**

Once you have brainstormed the similarities and differences, have decided the focus and thesis statement of your essay, the next step is to organize it. You can organize your essay according to the above-mentioned two approaches. It can be either through a point-by-point method or subject by subject method at [paper writer](#)
